AN ORDINANCE OF PYMATUNING TOWNSHIP, MERCER COUNTY, PENNSYLVANIA, DECLARING THE INTENTION OF THE SUPERVISORS OF PYMATUNING TOWNSHIP TO ACQUIRE LAND FOR THE ERECTION OF A TOWNSHIP BUILDING THEREON FOR USE AS A TOWNSHIP HALL AND FOR THE STORAGE AND HANDLING OF TOWNSHIP EQUIPMENT, MATERIALS AND SUPPLIES, AND AUTHORIZING THE PURCHASE OF SUCH LAND FOR THE SUM OF FIVE THOUSAND DOLLARS.

WHEREAS, the Township of Pymatuning, Mercer County, Pennsylvania, presently has no township hall or building, and has inadequate facilities for the storage of township equipment, materials and supplies, and there is a present need for the same which is expected to increase in the future, and in the judgment of the supervisors of said township it is deemed to be in the best interests of the township to acquire a tract of land for such purpose; and

WHEREAS, it is the intent of the supervisors of Pymatuning Township to purchase from the First National Bank in Sharon, for the price of \$5,000.00, the land hereinafter described for the purpose of erecting a suitable building thereon for use as a township hall and for the handling and storage of township equipment, materials and supplies,

NOW, THEREFORE, Be it Enacted and Ordained, by the board of supervisors of Pymatuning Township, Mercer County, Pennsylvania, and it is hereby enacted and ordained by the authority of the same as follows:

SECTION 1. That the Township of Pymatuning hereby declares its intention to purchase the land described as follows from the First National Bank in Sharon, Sharon, Pennsylvania:

ALL that certain piece or parcel of land situate in Pymatuning Township, Mercer County, Pennsylvania, commencing at a point in the Transfer-Hamburg Road leading from Route 18, which point is 435.6 feet west of the intersection of the Transfer-Hamburg Road with State Highway Route 18 measured from the west edge of the concrete pavement as now constructed; thence along the center line of said Transfer-Hamburg Road a distance of 500 feet to land of Horton; thence south 3° 45' east along the land of

Horton a distance of 1110.52 feet to a point; thence south 84° 45' east along other lands of First National Bank in Sharon to an iron pin; thence north 3° 45' west along the lands of Lescisin et al a distance of 1116.50 feet to the center line of the Transfer-Hamburg Road, the place of beginning, and containing twelve acres, more or less.

for the purpose of erecting thereon a building to be used as a township hall and for the handling and storage of township equipment, materials and supplies for the purchase price of \$5,000.00.

SECTION 2. That upon the effective date of this Ordinance, the Township of Pymatuning be and is hereby authorized to pay the First National Bank in Sharon the purchase price of \$5,000.00, provided the title is found to be good and marketable, with payment to be made upon delivery by the First National Bank in Sharon of a general warranty deed conveying the above described land.
