AN ORDINANCE OF THE TOWNSHIP OF FYMATUNING, COUNTY OF MERCER COMMONWEALTH OF PENNSYLVANIA, DEFINING DISORDERLY CONDUCT, XXXXXX DEALARING DISORDERLY CONDUCT TO BE UNLAWFUL AND PROVIDING PEN-ALTIES FOR THE VIOLATION OF THE ORDINANCE.

BE IT ENACTED AND ORDAINED by the Board of Supervisors of Pymatuning Township, Mercer County, Pennsylvania, and it is hereby enacted and ordained by and with the authority of the same as follows:

BECTION I.It shall be unlawful and shall constitute disorderly

conduct for any person Wilfully;

(a) To make a loud, boisterous, or unseemly noise or disturbance or to use violent, profane, blasphemous, indecent, or immoral language upon or near any public place within the Township or in a manner so as to annoy residents in the neighborhood, or to cause annoyance by any disturbance or breach of the peace to the peaceable residence

nearby.

(b) To go about from place to place or loiter within the limits of said Township without having a fixed place of residence therein, or being unable to give a reasonable account for their presence in such place, or to trespass on private property to the annoyance or

disturbance of any of the peaceable inhabitants thereof.

- (c) To be upon any street, lane, alley, public highway, or other public place within the limits of said Township while intoxicated to the annoyance of any of the peaceable inhabitants thereof.

(d) To engage in fighting, or rictous conduct, or to incite or encourage others to do so, or to engage in any unlawful act tending to imperal the personal security of any person or to endanger or injure

property within th Township of Pymatuning.

(e) To loiter or assemble with others upon or along the public streets, lanes, highways, sidewalks, or public places, within the limits of the fownship of Pymatuning, in such a manner as to interfere with, impede, or annoy the traveling publicor peaceable inhabitants of the

Township.

(f) To engage in any act or conduct which is detrimental to the public peace at or tends to subvert good order and tranquility within

the Township. SECTION 8 No prosecution shall be brought under this Ordinance for any act which would constitute a violation of the Motor Code of 1959

as amended, except as therein provided.

SECTION 5; Any person who shall violate any of the provisions of this Ordinance shall upon conviction thereof before any justice of the peace of the Township be sentanced to pay a fine of not more than \$100.00 and costs of prosecution, and, in default of payment of such fine and costs, to imprisonment in the Mercer County Jail for a period not exceeding thirty (30) days

33CATION 4; If any section, paragraph, subsection, clause or provision of this Ordinance shall be declared invalid, or unconstitutional, such invalidity, or unconstitutionality shall not affect or inpair the

remaining provisions of this Ordinance.
