An Ordinance of Pymatuning Township, Mercer County, Pennsylvania, supplementing the Pennsylvania Sewage Facilities Act and further regulating sewage disposal systems in Pymatuning Township.

BE IT ENACTED AND ORDAINED by the Board of Supervisors of Pymatuning Township, Mercer County, Pennsylvania, and it is hereby enacted and ordained by and with the authority of the same as follows:

SECTION 1: This ordinance shall be construed as supplementing for Pymatuning Township the provisions of the Pennsylvania Sewage Facilities Act, Act No. 537, approved January 24, 1966, hereinafter referred to as the Sewage Facilities Act.

SECTION 2: The fee for a permit to install a sewage disposal system as required by the Sewage Facilities Act, or as required by this Ordinance, shall be ten (\$10.00) Dollars. Such permit shall be valid for a period not exceeding 90 days, during which period the proposed construction shall be completed and ready for final inspection. Thereafter, permits may be received for an additional 90 day period at a renewal fee of five (\$5.00) Dollars for each renewal.

SECTION 3: The provisions of the Sewage Facilities Act as presently enacted, or subsequently amended, and all rules, regulations, standards and procedures adopted by the Department of Health of the Commonwealth of Pennsylvania, pursuant thereto, shall apply to all individual sewage systems or community sewage systems hereafter constructed with Pymatuning Township whether or not because of lot size and the same would be otherwise exempt from the provisions of the Sewage Facilities Act.

SECTION 4: The administration and enforcement of this ordinance and the Sewage Facilities Act shall be vested in an authorized representative of Pymatuning Township designated as such by the Board of Supervisors, which person may be jointly employed with other municipalities for such purpose

SECTION 5: No person shall install an individual or community sewage disposal system, or construct any building in Pymatuning Township in which an individual or community sewage disposal system is to be installed without first obtaining a permit indicating that the site plans and specifications of such system are in compliance with Act No. 537 and the rules and regulations adopted pursuant to the Act.

SECTION 6: Any person who shall violate any of the provisions of this ordinance and who is not subject to the penalty provisions of the Sewage Facilities Act, shall, upon conviction before any Justice of the Peace of the Township, be sentenced to pay a fine of not less than \$100.00 and not more than \$300.00 and costs of prosecution, and in default thereof shall undergo imprisonment in the Mercer County Jail for a period not exceeding 30 days.

SECTION 7: In the event any section, sentence or part of this ordinance is declared to be invalid for any reason, such invalidity shall not affect the remaining portions of this Ordinance.

SECTION 8: Any ordinance in conflict with this ordinance is repealed to the extent of such conflict.
