ORDINANCE NO. 79

An Ordinance amending Ordinance No. 28 of the Township of Pymatuning, Mercer County, Pennsylvania, which establishes certain traffic regulations in the Township of Pymatuning, establishing a speed limit of 40 miles per hour on certain roads, imposing a weight limit of ten tons on certain additional township roads, and increasing the maximum fine for violations from \$10.00 to \$50.00.

BE IT ENACTED AND ORDAINED by the Board of Supervisors of the Township of Pymatuning, Mercer County, Pennsylvania, and it is hereby Enacted and Ordained by and with the authority of the same as follows:

Section 1: That Section 4 of Ordinance No. 28 be and is hereby amended to add the following roads on which a weight limit of ten tons is hereby established:

Township Road No. 440 - Roynolds Rd. 10 tons
Township Road No. 639 - 1044 57 10 tons
Township Road No. 439 - Regardle Rd. 10 tons
Township Road No. 426 - Sherang, Park 10 tons
Township Road No. 617 - Mortimer Rd. 10 tons

Section 2: That Ordinance No. 28 be and is hereby amended to add the following additional Section:

Section 5A: A speed limit of 40 miles per hour is hereby established at the following locations:

Section 3: That Section 10 of Ordinance No. 28 be and is hereby amended to read as follows:

Section 10: Any person who shall violate any provisions of the ordinance or any amendment thereof shall, upon conviction thereof, be sentenced to pay a fine or penalty of not more than Fifty (\$50.00) Dollars and costs of prosecution, and in default of payment of such fine and costs shall be committed to imprisonment in the Mercer County Jail for a period of not more than five (5) days, except that where there is a specific penalty for such violation prescribed by the Vehicle Code of Pennsylvania, in which latter case the penalty shall be that provided by the Vehicle Code.
