AN ORDINANCE PROVIDING FOR THE HEALTH AND WELFARE OF THE TOWNSHIP OF PYMATUNING BY REGULATING THE COLLECTION AND DISPOSAL OF SOLID WASTE, THE LICENSING OF SOLID WASTE COLLECTORS, AND PROVIDING PENALTIES FOR THE VIOLATION THEREOF.

The Board of Supervisors of the Township of Pymatuning hereby ordains as follows:

Section I. Authorization of Collectors.

- (a) No person shall collect, remove, haul, or convey refuse from the Township of Pymatuning or dispose the same in any manner or place without authorization from the Township Board of Supervisors. Said collectors shall be duly licensed and pay an annual fee of Five and No/100ths (\$5.00) Dollars, for such license. Violations of any part of this Ordinance may cause the license to be revoked.
- (b) No authorized collector shall make any change in the arrangements for disposal of refuse collected by him without first receiving the approval of the Township Board of Supervisors.
- (c) Said materials shall be transported directly to the "Waste-to-Energy" facility designated by Township Board of Supervisors, or any other disposal facility as may be designated by the Township Board of Supervisors.

Section II. Disposal of Refuse.

- (a) It shall be unlawful to dump, bury, destroy, or otherwise dispose of refuse within the jurisdiction limits of the Township of Pymatuning.
- (b) Disposal of refuse shall be at the "Waste-to-Energy" facility or any other disposal facility as may be designated by the Township Board of Supervisors.

Section III. Penalties.

- (a) Any person who shall violate any provisions of this ordinance shall, upon conviction, be sentenced to pay a fine of not less than \$100.00 nor more than \$300.00, or in default of payment of such fine, then to imprisonment for not more than thirty (30) days.
- (b) Each day's continuance of a violation of this Ordinance shall constitute a separate offense.
 - (c) This Ordinance may be enforced by injunction.

Section IV. Non-Compatible Hazardous Materials.

- (a) The Waste-to-Energy facility operator shall have the right to refuse to accept any materials which may not be compatible with the disposal technology employed. The decision of the facility operator shall be subject to the review of the Township Board of Supervisors.
- (b) Hazardous waste and residual waste may be disposed of only in accordance with Rules and Regulations established by the Township Board of Supervisors for this purpose. If the Waste-to-Energy facility is unable to handle this material at its disposal site, it will be required that the generator of such waste make independent provision for its disposal, which will be in compliance with minimum standards of the Pennsylvania Department of Environmental Resources for hazardous waste as delineated in their most recent Rules and Regulations.
- (c) Collection and transportation of hazardous and residual waste, either by the generator of such wastes, an agent of the generator of such wastes, or others, shall be in accordance with the requirements of State and Federal regulatory controls for such waste.

Section V. Saving Clause.

The invalidity of any section or provision of this Ordinance shall not invalidate any other section, provision, or part of it.

Section VI. Effective Date:

This Ordinance shall become effective five (5) days after the adoption thereof.
