## ORDINANCE NO. /38

AN ORDINANCE AMENDING ORDINANCE No. 28 OF THE TOWNSHIP OF PYMATUNING, MERCER COUNTY, PENNSYLVANIA, ENTITLED, "AN ORDINANCE PROVIDING FOR THE ESTABLISHMENT OF CERTAIN TRAFFIC REGULATIONS IN THE TOWNSHIP OF PYMATUNING, MERCER COUNTY, PENNSYLVANIA, PROVIDING FOR THE INSTALLATION OF APPROPRIATE SIGNS TO GIVE NOTICE THEREOF AND REPEALING PRIOR ORDINANCES RELATED TO TRAFFIC REGULATIONS", BY PROVIDING FOR THE ESTABLISHMENT OF REDUCED SPEED LIMITS WITHIN SPECIFIED SCHOOL ZONES, THE INSTALLATION OF APPROPRIATE SIGNS TO GIVE NOTICE THEREOF, AND PROVIDING PENALTIES THEREFOR.

BE IT ENACTED AND ORDAINED by the Board of Supervisors of the Township of Pymatuning, Mercer County, Pennsylvania, and it is hereby enacted and ordained by and with the authority of the same and by virtue of the authority granted under the Vehicle Code of Pennsylvania, as follows:

SECTION 1: That Sections Five (5) and Six (6) of Ordinance No. 28 shall be amended by reducing the maximum speed limit in the specific locations, designated as School Zones, on certain days and hours, marked by official signs, as follows:

No vehicle shall be operated in excess of fifteen (15) miles per hour in any of the following locations between the hours and on the days hereinafter indicated:

SECTION 2: Official signs and signals shall be procured as may be required under any of the Sections of this Ordinance, or any future amendments or additions hereto which shall be erected, posted and maintained so as to properly give effect to the provisions of all of the Sections of this Ordinance and to properly comply with the law, including the requirements set forth in the studies furnished by the Pennsylvania Department of Transportation, and the signs or signals indicating the beginning and end of the aforesaid school zones and speed limit signs shall be installed at the following locations:

#### Brentwood Drive (Township Road 434)

- Sign No. 1 Easterly side of Brentwood Drive, 300' South of the center of the Reynolds Elementary School driveway.
- Sign No. 2 Westerly side of Brentwood Drive, 320' North of the center of the Reynolds Elementary School driveway.
- Sign No. 3 Easterly side of Brentwood Drive, 300' South of the centerline of Reynolds Road Extension.
- Sign No. 4 Westerly side of Brentwood Drive, 280' North of the centerline of the 15th Street.

# 2. Crestview Drive (Township Road 468)

Sign No. 1 - Westerly side of Crestview Drive, 310' North of the centerline of Reynolds Road Extension.

- Sign No. 2 Easterly side of Crestview Drive, 290' South of the centerline of Reynolds Road Extension.
- Sign No. 3 Westerly side of Crestview Drive, 300' North of the center of the East side driveway entrance to the Reynolds High School Parking Lot.
- Sign No. 4 Easterly side of Crestview Drive, 300' South of the center of the East side driveway entrance to the Reynolds High School Parking Lot.
- Sign No. 5 Westerly side of Crestview Drive, 300' North of the center of the Reynolds Elementary School driveway entrance.
- Sign No. 6 Easterly side of Crestview Drive, 185' South of the center of the Reynolds Elementary School exit driveway.

## 3. Edgewood Drive Extension (Township Road 635)

- Sign No. 1 Northerly side of Edgewood Drive Extension, 300'
  East of the center of the Transfer Elementary
  School East end driveway entrance.
- Sign No. 2 Southerly side of Edgewood Drive Extension, 300' West of the center of the Transfer Elementary School West end driveway entrance.

### 4. Reynolds Road Extension (Township Road 439)

- Sign No. 1 Southerly side of Reynolds Road Extension, 225'
  West of the center of Reynolds High School West
  end driveway entrance.
- Sign No. 2 Northerly side of Reynolds Road Extension, 250' East of the center of Reynolds High School West end driveway entrance.
- Sign No. 3 Southerly side of Reynolds Road Extension, 195'
  West of the center of Reynolds High School East
  end driveway entrance.
- Sign No. 4 Northerly side of Reynolds Road Extension, 165'
  East of the center of Reynolds High School East
  end driveway entrance.

SECTION 3: If any Section, clause, sentence or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses or sections, or parts of this

Ordinance. It is hereby declared as the intention of the Supervisors of Pymatuning Township, Mercer County, Pennsylvania, that this Ordinance would have been adopted had the unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included herein.

SECTION 4: The provisions of this Ordinance, so far as they are the same as those of Ordinances and Regulations now in full force and effect, prior to the enactment of this Ordinance, are intended as a continuation of such Ordinances and Regulations, and not as new enactments. The provisions of this Ordinance shall not affect any act done or liability incurred nor shall they affect any suit or prosecution pending or to be instituted to enforce any right or penalty or to punish any offense or offenses under the authority of any of those repealed Ordinances, Regulations, or parts thereof.

SECTION 5: All other Ordinances of the Township of Pymatuning not inconsistent herewith shall remain in full force and effect, and all Ordinances or parts of Ordinances in conflict herewith, are hereby repealed.

SECTION 6: This Ordinance shall become effective five (5) days after adoption hereof.
