

ORDINANCE NO. 170 - 1996

AN ORDINANCE AMENDING ORDINANCE NO. 79, AND 138 WHICH AMENDS ORDINANCE NO. 28 OF THE TOWNSHIP OF PYMATUNING, MERCER COUNTY, PENNSYLVANIA, ENTITLED "AN ORDINANCE PROVIDING FOR THE ESTABLISHMENT OF CERTAIN TRAFFIC REGULATIONS IN THE TOWNSHIP OF PYMATUNING, MERCER COUNTY, PENNSYLVANIA, PROVIDING FOR INSTALLATION OF APPROPRIATE SIGNS TO GIVE NOTICE THEREOF AND REPEALING PRIOR ORDINANCES RELATING TO TRAFFIC REGULATIONS", BY PROVIDING FOR THE ESTABLISHMENT OF A REDUCED MAXIMUM SPEED LIMIT ON CRESTVIEW DRIVE (TOWNSHIP ROAD NO. 468) FROM STATE ROUTE 4014 TO STATE ROUTE 4007 EXCEPT ANY PORTION THEREOF CONSTITUTING A SCHOOL ZONE; BRENTWOOD DRIVE (TOWNSHIP ROAD 434) FROM TOWNSHIP ROAD 639 TO TOWNSHIP ROAD 635; AND ARLINGTON DRIVE (TOWNSHIP ROAD 432) FROM TOWNSHIP ROAD 639 TO TOWNSHIP ROAD 635; THE INSTALLATION OF APPROPRIATE SIGNS TO GIVE NOTICE THEREOF; REMOVING THE SCHOOL ZONE SPEEDING RESTRICTIONS AND SIGNS FROM EDGEWOOD DRIVE EXTENSION (TOWNSHIP ROAD 635) AND PROVIDING PENALTIES THEREFOR.

BE IT ENACTED AND ORDAINED by the Board of Supervisors of the Township of Pymatuning, Mercer County, Pennsylvania, and IT IS HEREBY ENACTED AND ORDAINED by and with the authority of same and by virtue of the authority granted under the Vehicle Code of Pennsylvania as follows:

SECTION 1: Section 5 of Ordinance No. 28 be and is hereby amended to read as follows:

A maximum speed limit is established on portions of the specified street set below, and it shall be unlawful for any person to drive a vehicle, on any part of a street where maximum speed limit applies, at a higher speed than the maximum prescribed for that part of the street:

a.m. prevailing time

3. Arlington Drive Township Rd. 639 25 mph  
(Township Rd. 432) to Township Rd. 635

**SECTION 2:** Official signs shall be procured as may be required under this Ordinance and shall be erected, posted and maintained so as to properly give effect to the provisions of this Ordinance and to properly comply with the law, and regulations of the Pennsylvania Department of Transportation and shall be posted at the beginning and end of the speed zone set forth in Section 1 above, at intervals not greater than one-half (1/2) mile.

**SECTION 3:** Section 1, subparagraph 3 and Section 2, subparagraph 3 of Ordinance No. 138 of 1987 establishing School Zone speeding restrictions and signs therefor on Edgewood Drive Extension (formerly Township Road 635) are hereby repealed as the school building along this road has been closed.

**SECTION 4:** Any person who violates any provision of this Ordinance shall, upon conviction thereof, be sentenced to pay a fine and cost as prescribed by the Vehicle Code of Pennsylvania, or any amendments thereto.

**SECTION 5:** The provisions of this Ordinance shall be severable, and, if any of the provisions hereof shall be invalid or unenforceable, the remaining provisions of this Ordinance shall remain in full force and effect.

**SECTION 6:** The provisions of this Ordinance, so far as they are the same as those of Ordinances and Regulations now in full force and effect prior to the enactment of this Ordinance, are intended as a continuation of such Ordinances and Regulations and not as new enactments. The provisions of this Ordinance shall not affect any act done or liability incurred nor shall they affect any suit or prosecution pending or to be instituted to enforce any right or penalty or to punish any offense or offenses under the authority of any of those repealed Ordinances, Regulations or parts thereof.

**SECTION 7:** All other Ordinances of the Township of Pymatuning, not inconsistent herewith shall remain in full force and effect, and all Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

**SECTION 8:** This Ordinance shall become effective five (5) days after its adoption.

**ENACTED AND ORDAINED,** and finally into law by the Supervisors of the Township of Pymatuning, Mercer County, Pennsylvania, on this 17th day of October, 1996.
