

ORDINANCE 28

An Ordinance providing for the establishment of certain traffic regulations in the Township of Pymatuning, Mercer County, Pennsylvania, providing for the installation of appropriate signs to give notice thereof and repealing prior Ordinances relating to traffic regulations.

Be it enacted and ordained by the Board of Supervisors of the Township of Pymatuning, and it is hereby enacted and ordained by and with the authority of the same as follows:

SECTION 1.

It shall be unlawful for any person operating a motor vehicle or other vehicle to violate or fail to comply with the regulations hereinafter set forth pertaining to traffic in the Township of Pymatuning.

SECTION 2.

All motor and other vehicles shall stop in obedience to the stop signs now or hereafter placed at the following locations.

Southwest corner of the intersection of Township Road No. 641 and Township Road No. 432 on Township Road No. 641.

Northeast corner of the intersection of Township Road No. 641 and Township Road No. 432 on Township Road No. 641.

Northwest corner of the intersection of Township Road No. 639 and Township Road No. 432 on Township Road No. 432.

Southeast corner of the intersection of Township Road No. 639 and Township Road No. 432 on Township Road No. 432.

Northeast corner of the intersection of Township Road No. 440 and Township Road No. 434 on Township Road No. 440.

Southwest corner of the intersection of Township Road No. 639 and Township Road No. 434 on Township Road No. 639.

West side of Township Road No. 432 at the intersection of Township Road 432 and Township Road No. 635 on Township Road No. 432.

West side of Township Road No. 434 at the intersection of Township Road No. 434 and Township Road No. 635 on Township Road No. 434.

East side of Township Road No. 432 at the intersection of Township Road No. 432 and Township Road No. 434 on Township Road No. 434.

West side of Township Road No. 432 at the intersection of Township Road No. 432 and Township Road No. 434 on Township Road No. 434.

Southeast corner of intersection of Township Road No. 434 and Township Road No. 641 on Township Road No. 434.

Northwest corner of intersection of Township Road No. 434 and Township Road No. 641 on Township Road No. 434.

Southeast corner of intersection of Township Road No. 430 and Township Road No. 641 on Township Road No. 430.

Northwest corner of Township Road No. 430 and Township Road No. 641 on Township Road No. 430.

South side of Township Road No. 440 at intersection of Township Road No. 468 on Township Road No. 440.

Southwest corner of Township Road No. 439 and Township Road No. 438 on Township Road No. 439

SECTION 3.

The following locations are hereby designated as "No Parking Zones" and it is hereby declared to be unlawful to park any motor vehicle or other vehicles at said locations at any time:

- (a) On the West side of Pennsylvania Route 18 between Station 1221 plus 00 and Station 1233 plus 50

SECTION 4.

A weight limit as hereafter prescribed for motor vehicles is hereby established on the following Township roads:

- (a) Township Road No. 587 - six tons
- (b) Township Road No. 430 - six tons

SECTION 5.

A speed limit of 35 miles is hereby established at the following locations:

- (a) Township Road No. 635 from Highway Route 18 to Township Road No. 468

SECTION 6.

A speed limit of 25 miles is hereby established at the following locations:

- (a) Township Road No. 434 from Township Road No. 635 to State Route 43120 except any portion thereof constituting a School Zone
- (b) Township Road No. 452 from Township Road No. 635 to State Route 43120
- (c) Township Road No. 440 from Township Road No. 468 to Township Road No. 464
- (d) Township Road No. 458 from Township Road No. 440 to Township Road No. 459

- (e) Township Road No. 439 from Township Road No. 438 to Township Road No. 434 excepting any portion thereof constituting a School Zone
- (f) Township Road No. 639 from State Route 18 to Township Road No. 434
- (g) Township Road No. 645 from Township Road No. 432 to Township Road No. 434
- (h) Township Road No. 645 from Township Road No. 432 to Township Road No. 434
- (i) Township Road No. 655 from Township Road No. 432 to Township Road No. 434
- (j) Township Road No. 657 from Township Road No. 432 to Township Road No. 434
- (k) Township Road No. 659 from Township Road No. 432 to Township Road No. 434
- (l) All of Township Road No. 442

SECTION 7.

The proper officials of the Township are hereby directed to erect traffic signs to give notice of all of the regulations hereinabove designated.

SECTION 8.

This Ordinance shall constitute a repeal of all prior Ordinances of the Township regulating motor vehicular traffic.

SECTION 9.

If any section, sentence, phrase, part or word of this Ordinance is determined to be unconstitutional or invalid, such unconstitutionality or invalidity shall not affect or impair any of the remaining provisions of this Ordinance.

SECTION 10.

Any person violating any of the provisions of this Ordinance shall upon conviction thereof be subject to the fine or penalty imposed for such violation by "The Vehicle Code" of Pennsylvania.
